# NREMC joins statewide effort to tackle 40 service projects on Community Day

During Co-Op Month, we participated in Co-Op Community Day. This initiative, which saw nearly 40 unique projects across Indiana, exemplifies how electric cooperatives leverage their resources and skills to address specific community needs and create a lasting impact.

**Humane Society of Whitley County:** In collaboration with Purdue Extension Master Gardeners, NREMC staff tackled fall maintenance, cutting back overgrown areas and tidying the property line.

**Faith Christian Academy, Columbia City:** The preschool playground received an upgrade, including a new swing set, rock area, fresh mulch, and a roofed structure for outdoor toy storage.

**LC Nature Park, Roanoke:** An NREMC crew is scheduled to install an Osprey nest tower to support local wildlife conservation efforts.

Our commitment to the community goes beyond providing reliable electricity. Co-Op Community Day allows us to roll up our sleeves and make a real difference in the areas we serve. Neighboring electric cooperatives also participated in Co-Op Community Day. Kosciusko REMC delivered meals to people who are homebound. ## Tis the season for capital credits

One of the best things about being a co-op member is that you are not simply a customer but rather a member-owner. Your financial contribution (paying the bill) keeps your lights on but also helps run the co-op that powers more than 30,000 people in this community. A portion of that financial contribution is returned to you each year in the form of capital credits. As a member-owner, you receive capital credits each year based on your length of membership and energy usage. Starting on Nov. 26, check your credit amount at <a href="mailto:nremc.com/credits">nremc.com/credits</a>, or find it on your November or December bill.

Look for your capital credits on your November or December electric bill.



At NREMC, we're taking an innovative approach to solar energy that goes beyond power generation. Our agrivoltaics program combines solar panels with agricultural activities, creating dual-purpose land use that benefits our entire community.

The concept is simple but powerful: The space beneath and around our solar panels remains productive agricultural land. Sheep graze between panels, naturally maintaining vegetation while fertilizing the soil. Local beekeepers can establish hives, supporting crucial pollinator populations – including endangered monarch butterflies – while creating additional income opportunities. Some crops even thrive under panels, as

the partial shade reduces water stress and creates ideal growing conditions.

This initiative aligns perfectly with our cooperative principles that focus on education and concern for our community. By implementing agrivoltaics at our solar sites, we're not just managing energy costs; we're supporting local agriculture, enhancing environmental sustainability, and strengthening our local food systems.

# **ELECTRICAL SAFETY TIPS FOR HUNTERS**

#### Be aware of what's out there even in remote areas

Hunting season brings outdoors people of all skill levels and experience to rural Indiana, often to unfamiliar areas. While most hunters follow safe hunting practices, we want to remind hunters of the importance of always being aware of their surroundings and watching for electric power lines in the air and electrical equipment on the ground.

Skilled hunters understand the potential hazards of discharging a firearm. Though rare, both accidental and intentional damage to electrical equipment has occurred. Such damage can be costly and potentially dangerous if it causes fires.

We've put together some helpful tips and things you may not know about electrical safety when hunting. Be sure to read the box on the right for more.

We encourage all members to enjoy the great outdoors, but electrical equipment is even in remote areas and is sometimes hard to see. Please be aware of what's out there.

# TIPS FOR SAFE HUNTING

- Never shoot toward power lines, poles, or substations - stray bullets can cause delayed equipment damage and outages.
- Alert hunters on your property about power line locations.
- Stay alert in wooded areas where power lines may be less visible.
- Don't attach hunting equipment or deer stands to utility poles or towers. Energized lines and equipment on the poles can conduct electricity to anyone who comes in contact with them.



### A successful hunt starts with choosing a safe location

Many hunting accidents involving power lines occur during blind or tree stand setup in low-light conditions. Before dawn, when many hunters head out to prepare their positions, power lines can be nearly invisible against the dark sky. Always scout your location in daylight first, and mark the presence of any power lines. Be sure to maintain a safe distance of at least 30 feet from lines when placing elevated hunting equipment.
